MINUTES OF THE

THIRTY-SEVENTH ANNUAL MEETING OF THE SOUTHEASTERN SECTION of the

AMERICAN SOCIETY FOR ENGINEERING EDUCATION

April 14, 15, 16, 1971

The thirty-seventh Annual Meeting of the Southeastern Section of the American Society for Engineering Education was held on April 14, 15, 16, in Clemson, South Carolina, with Clemson University serving as host. The published list of registrants indicated an attendance of 285 men, of which 18 represented industrial exhibitors. There were 77 ladies present.

At the opening session, President Loring K. Himelright presided, making announcemnts, then giving special mention to the firms who supported the informal reception held Wednesday night.

Dean L. G. Rich, College of Engineering, Clemson University welcomed the group to the Clemson area and President R. C. Edwards, of Clemson University welcomed the group on behalf of the University.

Brother B. Austin Barry, Vice President, Sections East, honored the Southeastern Section with his presence at this Annual Meeting. He gave a brief talk at the General Session touching on Society Activities, especially the function of Guidance (Board of Engineering Cooperation), how ASEE can fund itself and reorganization.

Dean Rich introduced the Keynote Speaker, Dr. Robert E. Uhrig, Dean of Engineering at the University of Florida. His talk on "The Engineer in Today's Society" was most informative as he examined the role of the engineer and how he interacts in society. Karl Johnson, Chairman of the Host Committee thanked Dean Uhrig for his excellent presentation.

Ross, presented the Annual Award of the Research Unit for Outstanding Contributions in Research to Dr. J. S. Wolf, Associate Professor of Materials Engineering, Clemson University, for his paper "The Role of Oxide Microstructure and Growth Stresses in the High-Temperature Scaling of Nickel." It was co-authored with F. N. Rhines and was published in the Metallurgical Transactions, Vol. 1, June 1970. President Himelright announced the winner of the Dow Chemical Award for 1971 was Jerry Counts of Virginia Polytechnic Institute and State University and the alternate went to John P. Anderson, University of Alabama at Birmingham. Entertainment following the banquet was introduced by Karl Johnson, Chairman of the Host Committee.
